

CDS512 Law and Ethics in Cyber Security (3 credit hours) Course Syllabus

Course Description

Law and Ethics in Cyber Security focuses on the ways that law, ethics and cyber security overlap and intersect. This course will also cover the laws related to intellectual property, civil litigation, criminal prosecutions, and privacy. An exploration of ethics and cybersecurity, as well as of workplace ethics will be covered in this course.

Course Learning Outcomes

By the end of this course, you will be able to:

- 1. Describe current laws, regulation, policies, and ethics as they relate to cybersecurity.
- 2. Describe intelligence gathering principles, policies, and procedures including legal authorities and restrictions.
- 3. Demonstrate how to communicate with all levels of management.
- 4. Demonstrate via recording or observation interpersonal and effective listening skills.
- 5. Propose a procedure for monitoring and assessing potential impacts of emerging technologies on laws and policies.

Time Commitment

Effective time management is possibly the single most critical element to your academic success. There will be a weekly discussion forum and written assignments. This course requires the development of a PowerPoint. A research paper on a topic of your choice related to the course content will also be required with individual elements due at various times throughout the course.
