

## **HCA643 Healthcare Policy, Law, and Ethics**

### **(3 credit hours)**

### **Course Syllabus**

---

### **Course Description**

This capstone course will require students to examine general healthcare administration issues within a framework of legislative issues and their impact on healthcare systems in the United States. Special emphasis will focus on the changes in federal governmental regulations and their impact on quality and financial administrative issues. Through the case study approach involving politics, policy, regulatory environments, economics and ethics, students will critically analyze issues for both healthcare providers and organizations related to corporate governance, personal choice, and regulatory compliance. Topics will include applied ethics, conflicts of interest, allocation of scarce resources, FDA regulations, confidentiality, payment policies, patient rights, data security, professional liability, and global competition.

### **Course Learning Outcomes**

By the end of this course, you will be able to:

1. Demonstrate an understanding of about how laws and ethics work together to provide safe, quality care.
2. Examine the American legal system in regards to how laws are made and who makes them.
3. Inspect the legal structure and governance of healthcare organizations.
4. Analyze the government's regulation of public health and health services.
5. Develop the ability to understand patient privacy and anti-trust laws on healthcare delivery.
6. Interpret the law of tort liability concerning negligence and malpractice.
7. Assess the effects of transparency, full disclosure and their effects on patient/family relationships during the delivery of care and management of untoward events.

## Time Commitment

Effective time management is possibly the single most critical element to your academic success. To do well in this online class you should plan your time wisely to maximize your learning through the completion of readings, discussions, and assignments. Because of our accelerated, seven-week term, TU online courses are designed with the expectation that you dedicate a little over **six (6)** hours per credit hour to course activities and preparation **each week**. For example, for successful completion of a three-credit, seven-week online course you should reserve roughly **twenty (20) hours per week**.

5. Major assignments and reflections are typically due by **11:55 p.m. ET on Sundays**.

## Learning Activities

You will complete multiple written assignments and activities each week (e.g., projects, critical thinking questions, case studies, and research/reflection papers, etc.) to improve your understanding of the course subject matter and to place yourself into real-world situations. In addition, we will engage as a class in one open forum discussion that will allow you to interact with your fellow students. Weekly quizzes in this course will cover textbook reading material, and, finally, a major project due in Week 6 will cover significant ethical and legal topics. As a

best practice, these creative activities will align closely with course outcomes and offer significant opportunities for you to apply target skills, knowledge, or attitudes to solving or analyzing real-world, authentic problems.
