

NAT321 Community and Public Health

(3 credit hours)

Course Syllabus

Course Description

Students are provided with an overview of past, current, and future status of community and public health, with emphasis placed on awareness and methods to improve existing status. Current health of the nation and society is assessed.

Course Learning Outcomes

By the end of this course, you will be able to:

1. Review the past, current, and future status of community and public health systems.
2. Identify and categorize key components of effective community and public health systems.
3. Analyze the state of national and societal health conditions and practices.
4. Investigate regulatory and non-regulatory efforts to offset threats to air, water, food, and the environment.
5. Identify best practices to support safety and health in the workplace.
6. Explore perceptions of community and public health through various cultural perspectives.

Time Commitment

Effective time management is possibly the single most critical element to your academic success. To do well in this online class you should plan your time wisely to maximize your learning through the completion of readings, discussions, and assignments. Because of our accelerated, seven-week term, TU online courses are designed with the expectation that you dedicate a little over **six (6)** hours per credit hour to course activities and preparation **each week**. For example, for successful completion of a three-credit, seven-week online course you should reserve roughly **twenty (20) hours per week**.

To help plan your time and keep on track toward successful course completion, note the distinctive rhythm of assignment due dates:

1. All times assume Eastern Time (GMT-4).
2. Weeks begin at 12:00 a.m. ET on Monday and end at 11:55 p.m. ET on Sunday.
3. Unless otherwise noted, initial assignments or discussion posts are due by **11:55 p.m. ET on Wednesdays**.
4. Additional assignments or follow-up discussion posts are due by **11:55 p.m. ET on Saturdays, and**
5. Major assignments and reflections are typically due by **11:55 p.m. ET on Sundays**.

Learning Activities

Each week, this course will feature discussion forums. Most weeks, there will also be a writing assignment or presentation assignment. You will end the course by submitting your final paper in Week 6 followed by an analysis and critical reflection in Week 7. Multiple assignments will help outline and prepare your final paper throughout the course.

Key Assessment (Taskstream Submission)

This TU course features a “Key Assessment” that provides you the opportunity to demonstrate your program’s core competencies. It also shows how the course fits within the broader curriculum. For this course, the Final Paper (due Week 6) is the key assessment.

Tips for Success

 - clearly indicate their grading approach (what they like to see in submitted work as well as what types of errors they tend to penalize more harshly),
 - thoroughly review and evaluate your submissions in a timely manner (in less than 5 days for most assignments), and
 - provide constructive feedback that indicates the strengths and weaknesses of your work and provides suggestions on how you can improve your performance on future assignments.
- Advocate for your success as a learner and help guide you toward successful completion of the course activities and most importantly, attainment of the course learning outcomes.
